



Marchinkoski stated "I'm sorry" and was immediately was placed into handcuffs. The merchandise was retained by store security (without any damage).

Store Security provided a sworn written statement detailing how Marchinkoski concealed meat before exiting the store without offering payment.

Based on the observations of store security, my observations, the physical evidence (merchandise, video surveillance), as well as the confession by Marchinkoski (total value of stolen items: \$102.50), Marchinkoski was arrested for 53a-125b; Larceny 6th Degree.

Marchinkoski was issued Misdemeanor Summons Complaint #MC 397311 for 53a-125b; Larceny 6th, and issued a court date of 12/22/16 at GA-09 at 0900 hours.

Marchinkoski stated that he stole the food in order to sell it for money for drugs.

The second suspect was also arrested for the same charge, and had been working alongside Marchinkoski.

REMARKS

On 12/09/16 at 2333 hours I, Officer Scrivo, responded to 106 Court Street, Mezzo Grille, for a report of a disturbance between at patron and staff of Mezzo. Upon my arrival, Officers Tiano and Liseo and Sergeant Mazzotta had taken the suspect, Mark Hodges into custody and placed him into handcuffs due to his combativeness with Mezzo staff.

I spoke with _____, who identified himself as a manager at the restaurant and a victim. _____ stated that Hodges was removed from the restaurant earlier due to him being out of control. A short time after he had been removed from the restaurant, Hodges reentered and began causing a disturbance inside of the restaurant and had to be removed again. Hodges then attempted to come back inside of the restaurant again and as he walked through the front door he punched _____ in the side of the face. _____ and other staff members of Mezzo forcibly removed Hodges again and in doing so, Hodges fell into a heat lamp located near the front door. The heat lamp was destroyed during the scuffle.

Hodges was intoxicated and claiming that he didn't do anything wrong and that there was no reason for him to be in handcuffs.

Sergeant Mazzotta requested to view the surveillance footage from the restaurant to verify the events

described by Sergeant Mazzotta and I were escorted to the business office where we were showed surveillance footage of the incident. Through the view of the front door camera, I could verify that Hodges was forcibly removed from the front door of the restaurant and as he was pushed backwards by staff, he knocked over the heat lamp. Through a view of the interior of the restaurant, I could observe a disturbance at the front door and described it as the incident in which he was struck in the face by Hodges.


was uninjured and did not require any medical attention and requested that Hodges be arrested. provided a written sworn statement to Officer St. Peter.

Hodges was issued a Misdemeanor Summons (MB982738) for Breach of Peace in violation of Connecticut General Statute 53a-181 with a pending court date of 12/23/2016, and released from the scene.
