REMARKS

On Dec 2, 2016 at approx. 2206 hrs. Colton Reilly was arrested and charged with being in violation of C.G.S. 14-301 Stop Sign Violation and 14-227a Operating Under the Influence after Police witnessed erratic driving on the vehicle he was operating.

During the Pre-exit interview, Reilly demonstrated characteristics of an impaired operator due to the odor of an alcoholic beverage, slurred speech and bloodshot glossy eyes.

Reilly was administered the Standardized Field Sobriety Tests by this officer to which I am POSTC trained to conduct.

Reilly failed all Standardized Field Sobriety Tests


Based upon the operation, the pre exit interview and the Standardized Field Sobriety Testing, this officer felt that enough probable cause existed to place Reilly under arrest for being in violation of C.G.S 14-227A Operating Under the Influence of Drugs and or Alcohol. Reilly was placed in hand-cuffs double locked and placed in my Middletown Police Cruiser. Reilly was transported to Middletown Police Headquarters for processing.

Due to Reilly's apparent level of intoxication, vomiting and inability to stay conscious, Reilly was transported to Middlesex Hospital for possible alcohol poisoning. Further tests were discontinued for Reilly. This officer took the inability of Reilly to perform tests as a refusal which was witnessed by Officer Mudano. Prior to being transported to Middlesex Hospital for treatment, Reilly was issued an MSC #MC378265 for being in violation of C.G.S. 14-301 Failure to Obey Stop Sign and 14-227a Operating Under the Influence of Drugs and or Alcohol. Reilly was able to sign the form as well as his Appearance bond where he was released on a \$500.00 Non-surety Bond. Reilly was given a court date of December 16, 2016 GA 9 1 Court St. Middletown, CT.

This officer conducted a follow up to Middlesex hospital where Reilly was being treated for the alcohol. The on call Doctor did not draw blood which would allow this officer to apply for a search warrant. The on call Doctor did however fill out an Impaired Driver form which was submitted to the Department of Motor Vehicles. The Doctor on call at the time was




REMARKS

On 12/3/2016, at approximately 0513 hours I, Officer Foster, was traveling Northbound in a marked Middletown Police cruiser on East Street. Traveling Southbound was a tan Ford Taurus, bearing CT registration AF55221, moving at a high rate of speed. Prior to the vehicle passing me, I observed the vehicle travel over the double yellow median into my travel lane. I conducted a motor vehicle stop for the violation. One of the passengers was identified as Rudolph McNeil by his Connecticut ID card. Upon detecting the odor of marijuana, I requested that all occupants exit the vehicle.

As McNeil exited the vehicle a baggie of suspected crack cocaine fell off his lap onto the pavement. The substance was field tested with NARK kit #3 which yielded positive results. A further search of McNeil's person yielded another baggie of suspected crack cocaine in his upper right pocket. All mentioned contraband was seized as evidence. The two baggies were later weighed to .67 grams using a department scale.

McNeil was placed in the back of my patrol vehicle and was transported to Police HQ for processing. was given a verbal warning for the motor vehicle offenses. McNeil was charged with violation of C.G.S. 21a-279(a) Possession of Narcotics (Sub Offense). McNeil was released on a \$5,000 non-surety bond and is scheduled to appear in Middlesex Superior Court on December 16, 2016 at 0900 hours.

REMARKS

On Friday, December 9th, 2016 at 19:19 hours, I, Officer Ortiz was dispatched to the parking lot 272 East Main St. Middletown on an unruly customer at Big Cheese Pizzeria. Dispatch radioed that the caller is reporting that the individual appeared to be intoxicated and is now getting into a red SUV bearing Ct. registration 770 UZT. Dispatch said the vehicle is a red 1996 Chevy Blazer.

I arrived to said location immediately since I was only several blocks away. As I pulled up to said location, I observed a male waving his arm and pointing to his right. It appeared that he was telling me the operator left north bound on East Main St. I drove north on East Main St. and then east on Silver St., at which point, I observed a red SUV bearing Ct. Reg. 770 UZT. The vehicle then went north on Walnut St. and then pulled into the driveway of 16 Walnut St.

I then activated my overhead emergency lights and siren in front of said location. The driver and lone occupant exited the vehicle and began to stumble. He held onto to the side of his vehicle to keep from falling. He was later identified by his Ct. operator's photo license #024097030, as **Jose A. Rivera**.

I asked Jose if he had just left Big Cheese Pizza, he said, "yeah, I always go there." I asked him what happen, he replied, *that fucking bitch was pissing me off, fuck her.* At this point,

As I spoke with Jose, I detected a strong odor of an alcoholic beverage emanating from his breath. Initially, Jose said he had 2 Budweiser beers. When asked again, he said he had about 4-5 beers. Jose presented with slur speech and red blood shot eyes.

I asked Jose if he be willing to perform a field sobriety test, to which he agreed. Jose Failed the field sobriety test and taken into custody and transported to police headquarters for processing Jose was read his Miranda warning. Jose said that he's been through this before and understood his rights. Jose was afforded an opportunity to contact an attorney.

The first breath test was administered at 20:10 hours and registered a blood alcohol count of 0.2142. The second breath test was administered at 20:40 hours at least ten minutes after the first test and registered a blood alcohol count of 0.2133.

Jose was charged with driving under the influence of alcohol and or drugs, 14-227a. Jose was released on \$500 non surety bond. He was assigned a court date of 12/21/16 to appear at GA 9 at 09:00 hours. Jose was provided with all his personal properties and documents prior to being released. Jose was released to his wife, without incident.

Note: Jose was arrested for DUI by this agency on 02/17/2001.

REMARKS

On 12/11/2016 at approximately 0038hrs Police were dispatched to a evading crash that happened in the parking lot of Middletown Brook near # 1231. It was learned that a witness had observed the crash and called it in describing the evading vehicle as a dark colored BMW SUV. Officer Woolard who had been in the area had observed a similar vehicle with damage just prior to the call coming in and remembered the registration number as AF89757. A records check of the registration revealed that the vehicle was registered to Anna Magiera out of 40 East Mount Rd, Middletown CT. Officer's were dispatched to the address and located the vehicle with the accused inside the drivers seat with the headlights on and the key in the ignition. The accused had her head back in the seat and was passed out. After interviewing the accused, and administering the Standarized Field Sobriety Tests, she was placed under arrest and transported to HQ where she was processed. REMARKS

MR. WHITE was issued a misdemeanor summons and was charged with the following:


