

### REMARKS

On 12/01/2016 the CT Adult Probation Middletown Office requested assistance of the Middletown CT Police Department with a client, the accused, who may be in possession of guns. The accused is a convicted felon as of 07/19/2011 and is on probation.

The accused was arrested by the CT State Police Troop F on 05/01/2010 and charged with:

Larceny Sixth Degree, 53a-125(b) and Robbery Third Degree, 53a-136a, with a verdict date of 07/19/2011, 4 years Jail, 10 month to serve, consecutive.

The accused was arrested by the Middletown CT Police Department on 05/01/2010 and charged with:

Burglary Third Degree, 53a-103, Verdict Date: 07/19/2011, 20 Month Jail, Concurrent  
Theft of a Firearm, 53a-53a-212, Verdict Date: 07/19/2011 4 Years Jail, 10 Months to Serve, Consecutive  
Violation of Protective Order, 53a-223\*, Verdict Date: 07/19/2014 20 Month Jail, Concurrent.

The accused had to surrender all firearms he possessed.

On 11/30/2016 the accused told his live in girlfriend that he would "blow his brains out" with a gun. The girlfriend also stated that the accused had a gun in the house.

Middletown CT Adult Probation acted on information that the accused may be in possession of guns, in violation of the accused' s probation and CT State Law, being a convicted felon.

The Adult Probation asked that the Middletown Police Department standby to assist while the accused is interviewed at the Adult Probation Office on 12/01/2016. (Due to the possibility that the accused could be armed with a firearm) Adult Probation had contacted the accused and asked that the accused meet with his Probation Officer at about 16:15 hours 12/01/2016.

The accused arrived at the Adult Probation Office and met with his Probation Officer. The accused granted Adult Probation permission to search the vehicle he drove to the Probation Office and his home at 6 Lindsey Road, Middletown, CT. The vehicle was searched by Adult Probation and no firearms were found.

Adult Probation, the accused and members of the Middletown CT Police Detective Division went to 6 Lindsey Road, Middletown CT and Adult Probation conducted a search of 6 Lindsey Road. Adult Probation found bullets, guns, gun parts, primers, and bullet casings.

Adult Probation found items that put the accused in violation of his probation and State Laws:

13 Hand Guns, 44 and 45 Calibers  
1 Long Gun (rifle) 50 Caliber  
2000 Live Bullets

Adult Probation handed over the found violation items to the Middletown CT Police Department at the end of their search.

The accused was brought to the Middletown CT Police Station and booked, charged with the aforementioned criminal charges. The accused was held on a \$250,000.00 bond.
