Hunt was taken into custody and brought to the booking area of the Police department where he was read his rights, fingerprinted, and processed.



The warrant was cancelled through dispatch and they provided me with



REMARKS

On Friday 11-18-2016 at approximately 1115 hours I, Officer Lathrop, was dispatched to an address on Silver Street on a report of a domestic disturbance. MPD dispatch advised two probation officers were at the residence attempting a home visit with a client when they overheard what they believed to be a physical domestic taking place inside the residence.

Probation Officers waited at the residence until Police arrived. On our arrival the suspect, Terence Wilford was detained outside pending the investigation. The victim had visible injuries to the neck area and gave a statement which alleged Wilford had assaulted him/her inside the residence. Probation also gave a statement with included hearing what they believed was a physical domestic inside the residence.


After speaking to the victim and the Probation Officer it was determined there was enough probable cause to arrest Wilford. Wilford was placed in the rear passenger side of a marked MPD police vehicle and transported to MPD


headquarters for processing.

Once back at MPD headquarters I advised Wilford of his Miranda Rights in writing which he acknowledged and signed. Wilford was fingerprinted, processed and photographed under UAR# 8873717 in violation of C.G.S. 53a-182 Disorderly Conduct and 53a-61 Assault in the Third Degree. Wilford was held in a MPD holding cell on a \$25,000 cash or surety bond and issued a court date of 11-21-2016 at GA-09.

A records check of Wilford revealed 21 prior arrests with convictions of Violation of a Protective Order, Disorderly Conduct, Assault 3rd, Assault 2nd, Probation Violation, Robbery 1st, Sale of a Controlled Substance, Interfering/Resisting, Failure to Appear, Breach of Peace, Risk of Injury, Assault on an Officer, and Larceny 6th.

It should be noted that during the booking process Wilford was verbally abusive to Officers calling them derogatory names.

REMARKS

On November 18, 2016 at approximately 1745 hours I (Ofc. Tiano) and Ofc. Terribile responded to a known address within the City of Middletown.

Upon arrival we met with the Complainant, who appeared extremely intoxicated and upset. The Complainant explained to us that her and her boyfriend Thomas Breedlove got into an argument. We then spoke with Breedlove and were unable to substantiate either individuals claim of events.

After having Dispatch check both individuals information through the system, it provided a Protective Order of Protection with Breedlove as the defendant. Breedlove was restricted from having any contact with the Complainant and is in clear violation of his order.

At this time Breedlove was placed under arrest by handcuffing him, checking them for tightness, and double locking it. Breedlove immediately became irrational attempting to pull away and began yelling. After placing him in the rear of Police Cruiser #1404 Breedlove continuously smacked his head against the plexi glass. Breedlove continued to berate us by calling us "Faggots" and to "Suck his Dick," while en-route to

Police Headquarters.

Once back at Police Headquarters Breedlove continued to be uncooperative and aggressive in his actions and comments. Prior to processing Breedlove he was placed into the Emotionally Disturbed Cell to calm down. Upon Breedlove calming down he was read his Notice of Rights, which he acknowledged by signing at approximately 2215 hrs.

He was then fingerprinted and photographed, which provided a Uniform Arrest # 8873719 and charged with C.G.S 53a-223*; Violation of Protective Order. Breedlove was unable to post his \$25,000.00 Cash/Surety Bond and was placed into Middletown Police Department Male Cell #5 pending his arraignment at G.A #9 on November 21, 2016 at 0900 hours.



McGriff stated her neighbor was upset that she returned tupperware without a lid, which began an argument that eventually became physical.

I then spoke with , who confirmed the argument began over tupperware, but escalated from there. provided a sworn written statement that reads:

"On 11/17/16 at about 2:15PM, I went to my neighbor Alice McGriff's house to retrieve tupperware. McGriff came over with wrong tupperware so I declined to take it. McGriff came to my apartment and an argument arose. The argument escalated until McGriff hit me in the face. McGriff's boyfriend came and separated us. McGriff then came back and hit me in the face and punched me in my head, and hit my

head into the wall in my apartment, damaging my glasses. I called the police and stayed in my apartment until officers arrived."



REMARKS
